

PRIVACY POLICY

We respect your privacy

Advance Careers Pty. Ltd. respects your right to privacy and is committed to safeguarding the privacy of our customers and website visitors. We adhere to the Australian Privacy Principles contained in the Privacy Act 1988 (Cth). This policy sets out how we collect and treat your personal information.

"Personal information" is information we hold which is identifiable as being about you.

Collection of personal information

We would seek to only disclose information in good faith and where required by any of the above circumstances.
